

FACTS **WHAT DOES PFC FINANCE DO WITH YOUR PERSONAL INFORMATION?**

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> ■ Social Security number and income ■ credit history and assets ■ insurance claim history and employment information
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons PFC Finance chooses to share; and whether you can limit this sharing.

What we do

How does PFC Finance protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does PFC Finance collect my personal information?

We collect your personal information, for example, when you

- apply for a loan or open an account
- apply for insurance or show your government-issued ID
- provide employment information

We also collect your personal information from other companies

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes - information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates include companies like PFC Insurance, PFC Development and PFC Shared Services.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *PFC Finance does not share with nonaffiliates so they can market to you.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *PFC Finance doesn't jointly market.*

Other important information

Important Information about Credit Reporting. We may report information about your loan-related accounts to credit bureaus. Late payments, missed payments or other defaults on your account may be reflected in your credit report.
